Thanks for everyone's patience and cooperation throughout the hiring and onboarding process. Please do not hesitate to reach out if we can be of assistance.


# Updates from the States

#### Susan Adams, Legislative Liaison

Nine states (Arizona, Illinois, Nevada, New Jersey, New Mexico, New York, Oregon, Pennsylvania and Texas) introduced legislation to adopt the ASLP-IC in the 2025 legislative sessions.

At the time of this newsletter, Arizona's legislation has passed and awaits the Governor's signature. New Mexico's legislation failed to pass prior to the legislatures adjournment for the year. Oregon's legislation is effectively dead, despite intense multi-year legislative efforts by a number of occupational interstate compacts.

# Federal Update: SHARE Act

The States Handling Access to Reciprocity for Employment (SHARE) Act has been introduced in both the United States Senate and House. H.R. 2332 is sponsored by Rep. Tracey Mann (R-KS-1) and Rep. Joe Neguse (D-CO-2). S. 1101 is sponsored by Sen. Peter Welch (D-VT) and Marsha Blackburn (R-TN). The SHARE Act would authorize the Federal Bureau of Investigation to conduct criminal background checks for licensure purposes pursuant to authorization to practice through an interstate compact. This legislation is crucial to the operationalization of the ASLP-IC and other licensure compacts for healthcare professions as numerous states have faced issues obtaining authorization from the FBI to conduct criminal background checks for compact licensure. The ASLP-IC, ASHA, and numerous other compact commissions, professional associations, and board organizations stand in support of the SHARE Act to promote the operationalization of licensure compacts and further enhance licensure portability for healthcare professionals across the country.

## CompactConnect

CompactConnect is a collaborative, open-source project to develop a licensure compact data system. For an occupational licensure compact to operationalize, a data system must first be established. Compact data systems enable practitioners to apply for multi-state practice and for states to share necessary information about licensees.

To realize efficiencies, a shared use system is in development through the partnership of The Council of State Governments (CSG) and the three occupational licensure compact commissions of the Audiology and Speech-Language Pathology, Counseling, and Occupational Therapy Compacts. Pilot states are currently being onboarded to the system.

# Legal Corner

As we are rapidly approaching the operationalization phase of our work as a compact commission, there are many details that have consumed the time of our executive committee, support staff and delegates. Regarding the commission's data system, CompactConnect, we continue to meet with member states to ensure a smooth onboarding process and have developed the attestations and disclaimers required for legal compliance. Our partnership with the Counseling and Occupational Therapy Compact Commissions in the development of the data system continues to pay dividends as we share costs and efficiencies. This tri-partite partnership is a pioneer in the field of interstate compacts. We have collectively agreed on steps to protect our data system trademark and creation of an open-source license for current and future users of CompactConnect.

Regarding member state compliance, each member state should already have or be working toward an FBI criminal background check to become legally compliant to issue and accept compact privileges to practice. The Rules Committee is investigating potential rule development that could assist member state boards in substantially complying with criminal background checks in the event they are denied an Originating Agency Identifier (ORI) number by their respective State Information Bureaus. Updates regarding rule development will be emailed to delegates and member state administrators, as well as posted to the ASLP-ICC website. Member states should also have set or be setting a fee which out of state privilege to practice applicants will pay to hold a privilege to practice in their state.

It remains my honor to represent the ASLP-IC Commission and I am grateful and proud of the work we continue to do together. Onward!

## News from the Finance Committee

The last several months have seen the Finance Committee drafting the Commission budget for the 2025-2026 fiscal year. The proposed budget in the amount of \$166,160 includes Personnel (Executive Director), Office Operating Expenses, IT Expenses, Commission Expenses, and the Annual Commission Meeting. The funds for this budget will come from our funders, ASHA (79%), AAA (18%) and ADA (3%). This budget does not include ASHA's contribution. for the development of Compact Connect, the compact data system shared by the ASLP compact, the occupational therapy compact and the counseling compact.

The Finance Committee recommended a \$50 commission fee for each privilege to practice. It is anticipated that once the compact is fully operational and member states are issuing privileges to practice, this fee will enable the compact will become fully self-sufficient.

## News from the Rules Committee

Since our last newsletter, the Committee has finalized a proposed rule for the Commission's Administrative Fee, which is set at fifty dollars (\$50.00). The rule will be posted on the Commission website for public comment. After the comment period, any public comments received will be reviewed and taken into consideration when the final proposed rule is presented to the full Commission for approval by the member states. In addition to the proposed administrative fee, each member state will determine its "State Fee" that each state will charge to receive a privilege to practice in their state. The Committee drafted FAQs to address questions regarding the "State Fee" that member states will be charging.

The Committee is also working to amend the rule on criminal background checks to address circumstances in which some member states are unable to conduct FBI background checks. The Committee will be proposing changes that will address this situation.

The Committee meets monthly on the second Thursday of each month. Our meetings are open to the public to attend virtually.
